STROLLIN WILD sped to the lead at the start and set the pace into the turn, came under pressure from POST HASTE at the quarter pole quickly turned back rival's bid, saved ground entering the head of the lane, hustled along under right handed pressure, pulled away and was ridden out late. CREET tracked the early pace, launched a three wide bid at the top of the stretch, sustained a steady effort through the lane and cleared second best. POST HASTE was forwardly placed soon after the start, moved up to challenge STROLLIN WIND near the quarter pole but was no match for the eventual winner, ran on two wide into the upper stretch then steadily weakened in the final furlong. CREEK FRONT raced off the early pace, saved ground into the upper stretch and failed to threaten. CLEARLY CLOVER was away in good order then weakened off the early leaders, was not too far back three to four wide around the turn then faded in the lane. SOBER SOMEDAY raced in the back and had no response.
