SHANNON K raced just off mid-pack in early stages, hustled along two wide past the quarter pole, tipped out three wide entering the head of the lane, lacked a clear path, bumped outside running NO RHYME OR REASON off stride, muscled way into a path and got up- late. NO RHYME OR REASON tracked the pace in early stages, and raced three wide off the top pair late on the turn, came three wide in upper stretch, got bumped repeatedly by SHANNON K near the eighth pole, ran on and got edged by SHANNON K late. GISELE'S MAP led the way in opening stages, took on the challenge of LU'S TIME mid-way around the turn, battled on into the lane then got overtaken by outside duo near the final sixteenth. LU'S TIME was forwardly placed then advanced mid-way around the turn to challenge GISELE'S MAP for the lead, dueled outside of rival into the final furlong, got overtaken by the top pair in late stages and got edged for show. TENNESSEE GRACE raced in the back, saved ground, shifted out four wide in the upper stretch and had a mild improve. TOMMY'S CRUE raced in range along the inside, saved ground around the turn then gave way in the lane. SHAKIN SPICE raced off the pace, came three to four wide into the lane and never threatened. THE STEWARDS POSTED INQUIRY LOOKING INTO STRETCH RUN, AFTER EVIEW SHANNON K WAS DISQUALIFIED FROM FIRST AND PLACED SECOND FOR IMPEDING THE PROGRESS OF NO RHYME OR REASON NEAR THE EIGHTH POLE. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate final time available.
