GREY STREET vied in opening stages, tracked the leader around the turn, made a bid four wide entering the head of the lane, advanced then angled in while not clear causing FINAL DECREE to clip heels, ran on and got up late. MARSH CREEK vied for the lead in early stages then led the way around the turn, sustained response into the lane and got denied late. FLIRTIN AGAIN raced off the early pace, shifted wide at the head of the lane and cleared show. HARVEST N'HEARTH vied in early stages, chased two wide around the turn then weakened in the final furlong. PERSCRIPTURE raced off the pace, swung wide into upper stretch, shifted in and failed to threaten. FINAL DECREE vied in opening stages, tracked the leader around the turn, hustled along three wide into the upper stretch then clipped heels when GREY STREET drifted in and dropped back. AUX ARCS vied in opening stages, chased inside around the turn then faded in the lane. REMAINING NAMELESS was pulled up in opening stages and transported equine ambulance after the race. STEWARDS POSTED INQUIRY, IT WAS DETERMINED GREY STREET ANGLED IN NEAR MID-STRETCH IMPEDING THE PROGRESS OF FINAL DECREE, WAS DISQUALIFIED FROM FIRST AND PLACED SIXTH
