FIFTH OF MAY broke out bumping rivals at the start, set the pace on the inside, responded when roused in the stretch, pulled away under urging and was kept to the task. DAISY BELIEVES stalked three wide, bid between rivals at the quarter pole, then rallied mildly on the rail and earned the place award. ENGLISH ELSA stumbled and was bumped at the start, raced three wide off the pace, bid three wide at the quarter pole, then was outkicked for second. LADY CATALINA was bumped hard at the start, raced off the pace inside, chased on the turn, angled out and closed belatedly. MIA COUNTING stalked close up two wide, chased on the turn and tired. BRISCOE COUNTY was bumped hard and steadied at the start, trailed the field, came wide and failed to threaten. ALICE FANTASTIC was off a bit slow, raced off the pace inside and did not factor. REINVESTEDIVIDENDS was bumped and steadied at the start, raced off the pace between rivals, three wide on the turn and tired. GOTMISTYONTHEMIND tracked on the inside, checked in tight entering the turn and dropped back. After a Stewards' Inquiry into the start and a Jockey Objection by the rider of LADY CATALINA against the winner, FIFTH OF MAY was disqualified and placed eighth.
