DEAN OF BELONGING sprinted clear early, vied through the final turn then edged away in the final furlong. ROSIE OUTLOOK engaged the inner before half mile, dueled to mid-stretch then yielded in the late stages. ALWAYS IN PLAY moved close up in the two path then raced evenly in the final furlong. HOTTER THAN FIRE ducked in at the start bumping rival and having her heels clipped then lacked a rally. BULMA bid briefly on the final turn then weakened. ESSENTIAL GIRL was bumped then clipped heels at the start then no factor. IN THE BIZ stumbled badly unseating her rider at the start. The stewards conducted an inquiry into the start of the race and the rider of the sixth finisher claimed foul against the third and fourth finishers. HOTTER THAN FIRE was subsequently disqualified and placed sixth for interference leaving the starting gate.
