CHECK MY SIX saved ground throughout, lost the lead on the final turn to mid-stretch then came again in the final stages. YOUTBETTERBEJOKING set the pace off the inside, edged clear at the quarter pole but was out-finished. ALWAYS GAMBLING was in tight entering the first turn, vied between rivals then weakened. WARRIOR'S VENDETTA dropped far back between rivals then rallied mildly in the stretch. AMEDEUS MUSIC prompted the pace three and four wide and yielded in the stretch. RERALLY settled just off the pace in the two path under rating then faded. UNION LIGHTS saved ground while outrun and lacked a rally. VANZZY lacked speed, moved very wide on the final turn fading. A claim of foul by the third finisher against the winner for interference into the first turn was dismissed.
