NIXON JOY (ARG) trailed early, swung wide into the stretch and surged ahead late. CHACHACHING stalked the pace outside, edged to the front on the final turn, drifted out late and was nailed nearing the finish. WE READY settled off the pace inside, rallied in the final furlong then steadied slightly late. AHSAD settled close up outside then proved empty in the stretch. MALIBU WARRIOR alternated for the advantage inside then faded through the stretch. KEITHSENDSHELLOOOO lacked speed, moved very wide into stretch and was no factor. KERNESSE led briefly in the two path and stopped on the final turn. Th stewards posted an inquiry into the stretch run and the third finisher claimed foul against the second finisher for late interference but the result was allowed to stand.
