SOUNDSMISCHIEVOUS stalked the pace outside, took over after half mile and drew away under moderate urging. LAW SCHOOL settled inside the pacesetters, angled out then back in stretch at the top of the stretch and proved second best. MARILYN M moved clear opening quarter mile, was collared midway on the turn then weakened in the final eighth. MOON HALORY stumbled at the start, chased inside, then moved very wide on the turn and into the stretch.
