SHERUNSTHISTOWN dueled outside, moved clear on the turn and edged away driving. LADY SRIRACHA settled off the pace inside, angled out on the turn with a mild rally. BRISCOE COUNTY well placed outside the dueling leaders, bid on the turn then weakened. FLAMING EYES trailed for half mile then passed rivals near the inside. SPOOKY GAL dropped back after the start, swung extremely wide on the turn and stretch. MISS RAUCUS dropped back in the two path and weakened steadily. GIRL DYNAMITE vied along the rail with the winner to the turn and stopped.
