RINGER CARD led under pressure, ducked out with narrow lead fouling rival inside eighth pole and just lasted. MISSPENT advanced three wide on the turn then rallied while just missing. LEILAUNI SUE rated just behind the pacesetters, moved wide in the stretch and closed well. BROOKLYN RHAPSODY dueled outside, was soundly bumped inside the eighth pole then weakened. CALISA stumbled at the start while breaking alertly, moved close up then faltered. YOU KNOW ME angled wide on the turn and faded. WINE AND ROSES broke slowest and trailed throughout. Following a stewards inquiry and an objection by the fourth finisher against the first finisher for interference in the stretch, RINGER CARD was disqualified and placed fourth.
