PEARLS AND HEELS steadied along on the turn then steadied again in tight at the eighth pole. EDGE OF TOWN moved close up three wide then faded after half mile. AWESOME PIC rated off the leaders four wide and gave way. WINKIWINKI urged just off the pace inside, was asked for run on the turn and gave way.
