## Footnotes | View Glossary Of Terms

ALANI alternated for the lead inside in long duel, lightly bumped rival under left handled whip in mid-stretch then edged clear late. MEGA MIL dueled outside, was brushed by the winner in the stretch and continued gamely. BEACH DAZE dropped far behind then closed with a rush outside too late. TOP GUN GIRL saved ground off the leaders and raced evenly through the stretch. ECLAIR BLANC raced off the leaders inside and lacked a rally. NATURE'S CANDY went after the pacesetters on the turn then proved empty. DOCTOR ABBIE lagged very far behind and narrowed gap. BELLA QUEEN dropped well back and was never in contention. BURNER ACCOUNT flashed speed wide down the backstretch and stopped. The rider of the second finisher claimed foul against the winner for interference in the stretch but it was dismissed.
