LIGHT MY WAY vied for half mile then edged away under moderate pressure. KING DEIVYS lacked speed then rallied well inside to gain the place. COALVILLE settled inside dueling pacesetters, bid on the final turn then went evenly. EXTRASEXYMCSTEEMEE lacked speed then moved extremely wide on the final turn. EVASIVE MOVES trailed for five furlongs then passed fading rivals. SON OF DELILAH dropped far behind and was never in contention. LEGENDARY THUNDER moved close up initial quarter then faltered. KEEPING THE FAITH dueled between foes on the first turn and stopped. LYONZI dueled winner of half mile and stopped.
