CREAME SODA no menace. SEVEN PESOS lugged in, bumped hard, heels clipped, weakened. CYBER DYNASTY broke in, bumped hard. STREAKIN FAST WAGON pin balled, clipped heels, stumbled, taken in hand. CORONA SLIM pinched back start. A steward's inquiry was held concerning the running of the race. A trainer claim of foul was lodged by the trainer of STEAKIN FAST WAGON against the rider of SEVEN PESOS for interference twice in mid stretch. After reviewing the film's the steward's disqualified DECISIVE EAGLE from third and was placed fifth for interference in mid stretch. Also the steward's disqualified SEVEN PESOS from sixth and was placed ninth for interference in mid stretch.
