MF DEENA THE DEALER it tight late, taken up wire. SHES A WAR EAGLE broke out start, bumped. JORDASH JEANS no menace. LEAVIN SIXS shuffled back early. A claim of foul was lodged by the trainer of MF DEENAA THE DEALTER against the rider of MR ALTUNAR for interference in late stretch. A steward's inquiry was also held concerning the running of the race. After reviewing the film's, the steward's disqualified MR ALUNAR from third and was placed sixth for interference in late stretch.
