MOTHER OF PEARL set a pressured pace while outside, was well handled then drew off in late stretch and was best in the end. LADY BEAU was hustled along the inside to pressed the pace, stayed in striking position to late stretch but came up empty in the end. LOVEREIGNORME chased the early pace while two wide into the turn, made a bid but was no menace. ALISAL chased the early pace while inside, saved ground on the turn then faltered in the stretch. TODDY chased the early pace while three wide, was used up then gave way. HONEY CAFE was inside on the turn and no threat. JAUNTY was settled then failed to menace. DIALING FOR DOUGH was unhurried early then two wide on the turn and no threat. FREE TO BE ME was unable to menace throughout.
