KAUSE I'M DEVINE was allowed to settled in the early going, started a run into the far turn then moved out to be five wide in upper stretch, was in a strong drive and powered to the front in late stretch. ALL AMERICAN LADY was stalking the pace while inside on the backstretch, made a bid two wide on the far turn then moved out to be three wide for the stretch drive and was second best in late stretch. ANNIE'S JOY pressed the early pace while two wide on the backstretch, rallied to take command on the far turn then faltered in the stretch drive. IUKA MISS set a pressured pace from the inside, was in a long drive then weakened in the stretch. GOSPEL FABULOUS stalked the pace while three wide on the backstretch, made a bid on the far turn then flattened out in the stretch drive. GRACE GIVEN was four wide on the backstretch then failed to menace. TAPS MISTRESS was unruly in the gate then reared up at the start breaking in the air, was settled in the early going but was no threat in the stretch.
