BRAVITAS was unhurried early on then started a run on the far turn, was inside for the stretch drive and dug in gamely to proved best in a game effort. CURLIN'S UNION was allowed to settled then rallied on the far turn while three wide, was in a long sustained drive in the stretch but was out finished in the final strides. KOCHAN set the early pace then was headed on the backstretch, regained the lead on the far turn and drew off but could not last in late stretch. COWBOY CADE was allowed to settle while two wide on the backstretch, rallied on the far turn making a bid then flattened out in the drive. ENDUE was allowed to settled while inside and was no threat. VERRAZANO'S GOLD was unhurried early and no threat. PASSED PROMISE broke the left rein going into the first turn then ran off down the backstretch, bore out going into the far turn then was being eased up to the wire with help from the out rider and was walked off. PRINCE PIERRE was settled early on while two wide on the backstretch, bore out suddenly on the far turn and was pulled up in upper stretch then walked off. A steward's inquiry was held concerning the running of the race. After reviewing the film's, no action was taken.
