PROMISE ME BUCKS rallied four wide on the turn then made a bid but flattened out in the stretch. AROA was two wide into the turn then was blocked behind rivals at the top of the stretch, split rivals and failed to menace. SO WHATRO chased the early pace while two wide into the turn, was used up then faltered. KOLLYNS JULIE saved ground on the turn and faltered.
