WILBURNSCLASSYLADY stalked the pace while two wide on the backstretch, rallied on the far turn and took command then drew off in late stretch to be best. CASHMERE DANCER was unhurried early on then started a run into the far turn, swung out to be four wide in upper stretch and closed fast to be up for the place in the final stride. VIEWERS DISCRETION was allowed to settled then rallied two wide on the far turn, was making a bid in the stretch but was out finished for the place. SAN MATEO KAT set a well handled pace from the inside, was in a long drive on the far turn then faltered in the stretch. MISSINGYOU CRAZY was allowed to settled while inside on the backstretch then failed to menace in the stretch. TEMPLAR RED was stalking the pace while three wide on the backstretch and into the far turn, was checked slightly off heels in mid stretch and gave way.
