## Footnotes | View Glossary Of Terms

TELL ME WHEN set a well handled pace from the start, was challenged on the turn then drew off in upper stretch and was best in the end. CAJUN DOLL was saving ground into the turn then rallied while moving out to be three wide in upper stretch, was gaining ground but was second best. BEAU SOLEIL was three wide on the turn then made a late gain in late stretch but was no threat. BENDELENE pressed the pace while two wide into the turn, was in a long drive then faltered in the stretch. SHAWK'S LIL MIA was unhurried early and failed to menace. REGAL RUMOR raced four wide into the turn while being used up and faltered.
