ZE'BUL was allowed to settled while four wide on the backstretch, rallied five wide in upper stretch and was in a strong drive to powered to the front and drew away in the end. CHAPERONE was allowed to settled then saved ground on the far turn, rallied along the inside in the stretch but was second best. JUSTICE DEPARTMENT was allowed to settled while two wide on the backstretch, rallied four wide in upper stretch to be gaining but was no menace in late stretch. TEXAS CREED stalked the pace while two wide on the backstretch, rallied on the far turn to upper stretch then faltered. CASHMEUP was allowed to settled while three wide on the backstretch, made a bid on the far turn but flattened out in the drive. STONEY BRICK ROAD set a pressured pace from the start, was in a long drive then faltered.
