I REST MY CASE was settled on the inside in the early going, rallied three wide on the far turn and was in a long drive to proved best in the end. SWIFTLIKETAYLOR was allowed to settle in the early going while inside, rallied two wide into the far turn then made a strong bid three wide in the stretch drive but was second best in the end. HIGHLIGHT SHOW was allowed to settled then raced two wide on the backstretch, rallied on the far turn and was inside in the stretch but came up empty in late stretch. MISS POPULARITY was unhurried early then rallied on the far turn, was three wide in the stretch but was no menace. OVERTHROW was unhurried early then raced inside and failed to menace. JELLY ROAD was allowed to settled while two wide on the backstretch but was no threat in the stretch. RIVER BOMBER dueled for the lead while inside, was used up then gave way. COWGIRL COOL stalked the pace while three wide, was used up then gave way. ARIAS dueled for the lead while two wide on the backstretch, bore out into the far turn and faltered in the stretch. DAILY GIN was unhurried early and no threat.
