GORRONO RANCH was stalking the pace while inside, rallied and moved out to be four wide turning for home, was in a strong drive and powered to the front then held sway in the end. VAEDRA was allowed to settled then rallied on the turn, was five wide in upper stretch and was gaining ground willingly to finished well and be second best. GAMBLING DEN vied for the lead while inside, was in a long sustained drive but weakened in the stretch. DIALED INTO YOU was saving ground on the turn and rallied, made a strong bid but came up empty in late stretch. TATE BATZ was settled then rallied on the turn saving ground, was three wide in the stretch drive but was no threat. HELLO GOODBYE vied for the early lead while three wide into the turn, was in a long drive then faltered. SAY AS I SAY was unhurried early then made a mild rally but was no menace. GOLD MESA vied for the early lead while two wide, was used up then gave way. SANOVIV was unhurried early and no threat. TOPIC THUNDER raced three wide on the backstretch then made a five wide bid to the top

of the stretch and faltered in the drive. CHIP ALTERNATIVE trailed throughout.
