XYNGIN SPITFIRE rallied three wide on the turn making a bid but came up empty in late stretch. RASPBERRY MARTINI chased the early pace while two wide on the turn then was no menace in the stretch. BLING IT TO ME raced two wide on the turn and was no threat. HAPPY N SMILING was unhurried early then was inside on the turn and no threat.
