PERP WALK dueled for the lead while inside into the turn, was in a long drive but weakened in late stretch. DEVIOUS LOVER dueled for the lead while two wide into the turn, was in a long drive but weakened in the end. COUNTY JUDGE was hustled along the inside into the turn, was used up then gave way. RISKY WITH WHISKEY was allowed to settled while three wide on the turn then was no threat. MAJOR GRIFFIN was inside on the backstretch then saved ground on the turn but failed to menace. SHAGGY EDGE was unhurried early and no threat. TEXAN FARMER was shuffled back at the start, was hustled along to be in position while four wide then stopped in the stretch.
