MULTIPLE OPINIONS was settled then rallied four wide in upper stretch, was in a strong drive to take command in mid stretch then held sway in a game effort in the end. ADGER was settled then saved ground on the far turn, rallied and slipped through the inside and was gaining ground strongly but came up short in the end. CONFIDING was allowed to settled then rallied two wide on far turn and stretch, was gaining ground but hung in late stretch. DEPOSIT INSURANCE set the early pace then drew off into the far turn, was in a long sustained drive but weakened in late stretch. SPOONIE was allowed to settled then failed to menace. GOOD PRODUCT stalked the pace while three wide on the backstretch, was used up then gave way. DRAW YOUR BOW was unhurried early and no threat. SIPPIN SCOTCH chased the early pace while two wide on the backstretch, was used up then stopped.
