HEAVENVILLE set a well handled pace from the start, was in a long drive on the far turn to late stretch from between rivals and hung in late stretch. YO SOY ROY was allowed to settled while inside on the backstretch then failed to menace. CHAPERONE stalked the pace while three wide on the backstretch, was used up then faltered in the drive. JUSTICE DEPARTMENT was unhurried early and failed to menace. DRINKS AT THE CLUB was allowed to settled then failed to menace.
