TOWN HERO stalked the early pace while three wide on the backstretch, rallied on the far turn while saving ground, was in a strong drive and proved best in the end. AWOL was allowed to settled then raced two wide on the backstretch, rallied on the far turn then made a bid three wide in late stretch to be gaining and was second best. KOCHAN set the early pace and drew clear on the backstretch, was in a long drive then weakened in late stretch. BISHOP CREEK was allowed to settled then rallied four wide on the far turn making a bid but came up empty in late stretch. CODE ELEVEN was allowed to settled and failed to menace. STONINGTON raced four wide on the backstretch, was used up then gave way. DADDY SAID I COULD stalked the early pace while two wide, was used up then gave way. FALCON QUEST was inside on the run down the backstretch, dropped back before the far turn and failed to respond on the far turn.
