STONINGTON was allowed to settled in the early going, rallied on the far turn and swung out to be six wide in upper stretch, closed fast on the outside to be along in time. EXPENSIVE GAME was settled while inside on the backstretch, dropped back then rallied three wide on the far turn, split rivals in upper stretch and moved back to the inside making a strong bid but was second best. FALCON QUEST stalked the pace while three wide on the backstretch, rallied on the far turn and gained the lead in mid stretch, dug in but failed to last in a good effort. RICKIE ROOOO STER was settled while inside on the backstretch, saved ground on the far turn then made a bid three wide in mid stretch but was no menace in late stretch. CODE ELEVEN was allowed to settled while two wide on the backstretch, made a bid and moved out to be five wide in upper stretch but was no threat in late stretch. BISHOP CREEK was unhurried early then rallied four wide on the far turn making a bid but came up empty in late stretch. ROCKETS BLAZE was unruly in the gate then chased the early pace while two wide on the backstretch, made a strong bid on the far turn then faltered in the stretch drive. BANCHERO set the early pace from the inside, was in a long drive on the far turn and gave way in the stretch. HOPKINSVILLE chased the early pace while inside on the backstretch, was used

up then stopped. CONSTITUTIONREVIEW was unhurried early and outrun.
