TRESILLIAN had good early speed while two wide into the turn, drew off in upper stretch and was kept to task in the end while clear. TURQUOISE BLUE chased the early pace while two wide on the turn, made a bid but was no match for the winner in late stretch. DEVIOUS LOVER was bumped after the start then chased the pace while three wide into the turn, made a bid to mid stretch but weakened in late stretch. BEAU DAY pressed the pace while inside in the early going, was hard used then faltered. SHAGGY EDGE was settled then rallied and swung out to be five wide in upper stretch but was no threat. TO TOO TWENTYTWO bumped after the start then rallied four wide on the turn to make a bid but was no threat. CAJUN WARRIOR was inside on the turn and no threat. COUNTY JUDGE was bumped both sides after the start then raced four wide on the turn but was no threat in the stretch. FASTENED was unhurried early and three wide on the turn and was no threat. DICEY WAGER chased the early pace while inside, was used up and gave way.
