FLEXIBLE TERMS was allowed to settled while inside on the backstretch, saved ground on the far turn then rallied and moved out to be three wide for the stretch drive then powered to the front in late stretch to be best in the end. GOOD PRODUCT stalked the pace while three wide on the backstretch, rallied on the far turn and was two wide in the stretch and was second best late. LIFE AT SEA dueled for the lead while inside, was in a long drive then faltered in late stretch. RIDING DOUBLE was allowed to settled while three wide on the backstretch but failed to menace. INACCLASSOFMYOWN was allowed to settled then raced two wide on the backstretch and was no threat. DEPOSIT INSURANCE dueled for the lead while two wide on the backstretch, was used up then gave way in the stretch.
