CAJUN NINJA pressed the pace three-wide to the stretch, then chased ICY RIVER into the stretch, kept on well under steady handling, and wore down that rival in the shadow of the wire. ICY RIVER vied/dueled for the lead from the rail, gained sole command by upper stretch, dueled with CAJUN NINJA through the stretch, and gave way grudgingly in the final yards. SAINT SARENA settled at the back early, launched a bid from the three-furlong pole and rallied into third well behind the top pair. ACCELERATE JUDY broke slowly and a bit awkwardly, chased from last early, made a middle move on the turn but flattened out. KISS AND TELL pressed the pace from between horses, then faltered in the stretch. SAN MATEO KAT chased the trio on the front end from well behind, then tired in the stretch. CHILD PROOF was always behind and never threatened.
