LEGAL FICTION dueled from outside holding a slight edge over FALABELLA, battled head to head through the lane and dug in gamely to prevail. FALABELLA fought for the lead from inside, drifted out a bit at various points while battling LEGAL FICTION down the lane and got outgamed in the end. ROCK N ROLL SONG followed the dueling leaders closely from outside, rounded the bend three deep, finished willingly three deep but could not summon the needed final kick. HARNEY LANE chased two wide into the turn, between rivals around the bend, angled out in the lane and finished willingly to the wire. RYTHEM GIRL was forwardly placed from inside, hugged the rail to the stretch and never responded to urging. ROUSING JEWEL broke a step slow, angled out early and chased within striking distance, rounded the turn four then three wide, tipped out into the stretch and could not rally. NORTHERN ROSE dropped back early, saved ground through the turn and was outrun.
