TRACK AND TRACE (IRE) set the pace, then second on the backstretch for the final circuit, reclaimed the lead into the final turn, held a half length lead over the final fence, drew off under a mild hand ride in the stretch. RECOUP (GB) traveled in second for the first circuit, fifth on the hedge around the final turn, closed to second at the final fence, ran on well second best. COURT DUNN (IRE) close throughout, circled four wide on the final turn, avoided a faller landing the final fence, kept on for third. BOB'S BAR (IRE) rated midpack on the first circuit, took the lead on the backstretch for the final circuit, then weakened approaching the final fence. PAVONI rated midpack on the first circuit, pursued in third on the backstretch for the final circuit, then fell at the final fence when a close up third. MINELLA PLUS (IRE) was outrun and pulled up before the final fence. KIYOMORI bobbled a fence on the backstretch, dropped back to last and was pulled up before the last fence. ICE BAR jumped poorly, lost touch with the field and was pulled up.
