BRIE'S MISSION led on the turn into the backstretch, overtaken, dropped to fourth two hurdles out, stayed on. STEP OUT (IRE) stayed on but unable to close gap on foes. NEW APPOINTMENT (IRE) trailed throughout. GARRISON FOREST (IRE) was away alertly to a clear lead, passed briefly on the turn to the backstretch, regained the lead into the final turn and held a narrow lead when fell at the final hurdle.
