JOHN JOHN was allowed to settled in the early going, started a run into the turn then was four wide turning for home, powered to the front and was clearly best in the end. RAINBOW CREST chased the early pace while two wide on the backstretch, made a strong bid on the far turn then was up for the place in the end. MAXIMUM BULL was allowed to settled while inside on the backstretch, saved ground on the far turn then was no menace in late stretch. KHANTARO D'ORO set the early pace then drew off into the far turn, was in a long drive but weakened in late stretch. RIO CUTIE was inside on the backstretch then failed to menace. This race was originally hand timed and has been retimed using video technology to arrive at the most accurate final time. Due to a technical issue, fraction are not available.
