JEEPS STRIDE was allowed to settled then rallied three wide on the far turn, was in a strong drive and powered to the front in late stretch. ONE MARK vied for the lead while three wide on the backstretch, was in a long drive then tired in late stretch. DADDY WHAT IF was unhurried early then rallied six wide on the far turn and closed willingly in late stretch. READS PET ZENON was allowed to settled while two wide on the backstretch, rallied three wide in the stretch and made a mild gain in late stretch. PLAYING FIELD was allowed to settled while inside, saved ground on the turn then made a bid but was no menace in late stretch. BYE BYE MATTY P vied for the lead while two wide, was in a long drive then gave way. TATAS JOE MARK vied for the lead while inside, was in a long drive and gave way. RYDERS UP was unhurried early on while inside on the backstretch then was no threat. AARON WHO stalked the pace while three wide on the backstretch then faltered. CERVEZA was four wide and used up then gave way.
