CHAMPAGNE LANE tracked the leader on the inside up the backstretch, came around the turn in the three path, challenged in upper stretch and kicked clear. ONE HORSE TOWN dueled on the outside through the opening quarter, continued to battle from the two path around the bend and in upper stretch and could not go with the winner late but chased that rival home, before leaving the track in an equine ambulance. FINAL TRIAL dueled on the inside early, saved ground around the turn and gave way in the stretch. LION THRONE raced off the pace up the backstretch, came around the turn in the three path and made no bid. BOONE stalked the pace setters on the outside up the backstretch, dropped back to save ground around the turn and continued to fade in the lane.
