SWEET RIVER BAINES close up, pressed pace between, bid upper stretch, drew away. MISSISSIPPI MAN sent, showed speed to turn, outkicked stretch, second best. DISCREET MOB stalked outside, chased three wide to stretch, yielded, held show. PANUCO crowded start, chased two to three wide to stretch, no late kick. VINNIEBOB took back, coaxed two wide to stretch, gained, flattened out. UPWARD MOBILITY well placed inside, steadied midway through turn, no late rally. TARGARYIS took back, chased two to four wide to stretch, weakened drive. LEWIS BERE (FR) settled, swung six to seven wide upper stretch, no factor. WIND RIVER took back, tracked outside, asked five wide upper, no response.
