FIRE BOLT B quickly clear, held well. MR JESS EFFORT brush brk, bothered foe early. SHELL GAME light bump early, chased between. SHEZA GOIN COMFORT brush foe brk, kept on. DANZ AT COLFAX bothered, steadied early. WESTERN GRIT inside, no rally. HYNSON 2-3w, evenly. MS FERRARI DIABLO bump early, faded. FOLLOWING AN OBJECTION BY THE RIDER OF DANZ AT COLFAX AGAINST MR JESS EFFORT ALLEGING INTERFERENCE, THE LATTER WAS DISQUALIFIED FROM SECOND AND PLACED FIFTH BEHIND THE FORMER.
