STAKES Sunland Park Oaks Black Type - Thoroughbred  
FOR FILLIES THREE YEARS OLD. Lasix not permitted per Hisa Rule 4212(d). Free to nominate; \$1,000.00 to enter. Horses that were not nominated, must pay a \$10,000 Supplemental fee at the time of entry. Lifetime earnings will determine the order of preference of horses entered. Weight; 121 lbs. Certain finishing positions in this race will earn points to qualify for the 2024 Kentucky Oaks, pursuant to the rules published by Churchill Downs Incorporated. The winner of The Sunland Park Oaks will be awarded 20 points, the second place finisher 10 points, third place finisher 6 points and fourth place finisher 4 points, the fifth place finisher 2 points. First preference to highest earnings in a graded stakes, second preference to highest lifetime earnings at time of closing nominations. This race will be limited to twelve starters. A suitable award will be presented to the winning owner. After payment of 1% to all owners finishing six through last, The remaining purse will be distributed as follows 60% to the winner, 22% to second, 10% to third, 5% to fourth, 3% to fifth. Nominations Closed On Saturday February 7, 2026 At 4:00 P.M. with Fifteen.

BOTTLE OF ROUGE close up in the early stages, tracked three wide to the half, bid at quarter pole, took command to upper stretch then swerved out nearing the furlong grounds, corrected and kept to task into the final sixteenth and proved best late. TOUCH OF MAGIC settled to half, roused widest upper stretch, closed willingly and was second best. PASHMINA settled outside, asked four wide upper, steadied behind the swerving leader at mid-stretch, was outkicked late and was clear of the rest for third. COFFEE CONNECTION broke alertly, attended pace to half, outkicked to mid-stretch, faded late. NOT A LADY settled inside, well placed to far turn, got caught in traffic approaching upper stretch, was outkicked to the furlong pole and lacked a late rally. CASHED sent, solid pace from the inside to the half, overtaken nearing the quarter, chased to upper stretch then weakened in the lane. IN THE AGGREGATE shuffled at the start, trailed to the half mile, no factor. THE STEWARDS CONDUCTED AN INQUIRY INTO THE STRETCH RUN. IN ADDITION, THE JOCKEY OF PASHMINA LODGED AN OBJECTION AGAINST THE JOCKEY OF BOTTLE OF ROUGE, CLAIMING INTERFERENCE AT THE EIGHTH POLE. THE STEWARDS RULED THERE WOULD BE NO CHANGE.
