AB LEAVING YOU off bit slow, off pace to mid-stretch, responded late, up for 3rd. GP TWOS RESERVE showed speed, drifted out early, outkicked to deep stretch, gave way late, lost 3rd. MY LADY IN LIGHTS bobbed, broke in start, chased to mid-stretch, no final kick. RC A FLASHN CARTEL chased to mid-stretch, needed more late. KELLY GHOSTED ME crowded start, chased to mid-stretch, no rally, folded late. ROCK N ROLL GP off slow, off pace to mid-stretch, mild late rally, no threat. MARSHALL HOGAN stumbled, broke in start, chased to mid-stretch, outrun late. RED QUEEN MERCEDES off slow, lost path early, off pace to mid-stretch, no late bid.
