UPWARD MOBILITY settled off the pace before moving up near the quarter pole to run down the leader in the stretch to win the nod at the wire. MALIBU RAIN was away alertly to go to the front to set the pace with a clear lead to the top of the stretch but was headed near the sixteenth pole and fought gamely to the wire and was outnodded. VINNIEBOB raced off the pace from two wide but was no match for the top two and proved best of the rest. LEWIS BERE (FR) raced off the pace around the first turn then settled in the middle of the pack through the final turn, tipped out to three wide in upper stretch but lacked the late response. HOLLAND raced near the back and was not a threat. LORD WIMBORNE (IRE) was allowed to settle at the back and remained back. MAJOR CONTENDER reared at the start and lost rider. STEWARDS INQUIRY INTO THE START, AFTER A REVIEW IT WAS DETERMINED THAT MAJOR CONTENDER CAUSED HIS OWN PROBLEMS AND WAS DECLARED A STARTER.
