THREE MARTINIS raced in the middle of the pack around the first turn then steadily advanced from five wide to engage the leader midway through the final turn and drove past him to clear late. MAXIMUM BULL raced five wide into the first turn while tracking the leaders, moved up to take the lead near the three furlong marker but was overtaken near the quarter pole and kept on to be second best. GRIFTER raced five wide into the first turn then settled near the back before moving up from four wide near the half mile marker and was a clear third. CERVEZA stalked the pace from three wide around the first turn then took the lead midway down the backstretch but was collared near the three furlong marker before fading. DADDY WHAT IF was allowed to settle at the back then moved up but lacked room on the final turn and had to steady midway through but was able to find an opening in early stretch to improve his position. ARCH CITY raced in the middle of the pack through the final turn, tipped out to seven wide in upper stretch but was not a factor. COMING ABSTRACTION settled in the middle of the pack while saving ground around the first turn then fell back going into the final turn, tipped out to eight wide in upper stretch but had no impact. JEEPS STRIDE raced off the pace on the inside but lacked a bid and was not a threat. KING BRYCE vied for the lead from two wide around the first turn then fell back on the backstretch, tipped out to six wide in upper stretch but was empty. WILD FIREWATER went to the lead from the inside to midway down the backstretch then vied for the lead to the three furlong marker before retreating.
