EXPO CITY reared up leaving the gate, raced in the two path around the first turn, trailed the field up the backstretch, began a bid entering the second bend, entered the stretch in the three path and kicked clear. TORREADO veered out at the start, raced in the two path early, cussed the leader on the outside up the backstretch, saved ground around the far turn and kept on to the finish. STREET COLORS saved ground around the first turn, led the way on the inside up the backstretch, navigated the far turn from the three path and weakened in the lane. TONI THE GRRREAT hopped up at the start, raced in the middle of the pack in the three path around the first turn and up the backstretch, came around the far turn still in the three path and made no bid. AN INQUIRY WAS MADE INTO THE START. UPON REVIEW, NO CHANGES WERE MADE TO THE ORDER OF FINISH.
