CGR WINNR WONDERLAND chased to mid-stretch, no match late for top 2, up for 3rd. HILL COUNTY COWGIRL bobbled, broke out start, chased inside, no match top 2, lost 3rd. PERIKINA crowded start, chased to mid-stretch, needed more late. RR CORONADOS DELITE bobbled, came out at start, off pace to mid-stretch, no late bid. SUES DYNASTY off slow, crowded start, off pace to mid-stretch, no threat. MY FIRST CORONADO hit gate start, lugged in to mid-stretch, outrun final 110.
