ER SURFIN FOR CANDY vied early, dueled inside to mid-stretch, battled late, missed. FAVORITE FENDI hopped, crowded start, chased to mid-stretch, closed late, missed. EYESA SPECIAL MIKEY crowded, in tight at start, off pace to mid-stretch, no rally. BDS SHES A BADGER broke in, vied early, dueled to deep stretch, dug in late, nod. WHATA BULLET up close, chased to mid-stretch, in range late, outkicked. BRINDIS PROUD bobbled start, lugged out nearing mid-stretch, no late bid. DOCS BEST RETURN jostled and in tight to mid-stretch, no late response. ER JESS A PARTY crowded, shuffled after start, angled out, no late response. RAELEES TUFF CREEK came in after start, lugged in mid-stretch, off pace, no late bid. THERE WAS A STEWARDS' INQUIRY INTO THE RUNNING OF THIS RACE. IN ADDITION, THERE WERE OBJECTIONS LODGED FROM THE RIDER OF DOCS BEST RETURN AND THE TRAINER OF BRINDIS PROUD, CLAIMING INTERFERENCE. THE STEWARDS RULED RAELEES TUFF CREEK TO BE DISQUALIFIED FROM FIFTH AND PLACED NINTH, AND RULED BRINDIS PROUD DISQUALIFIED FROM SIXTH AND PLACED SEVENTH.
