SILVER N NAVY got away well, raced close in and surged late to prevail. FIVE BAR CAROL broke well and made the early running but was tagged at the wire. JV WOOD B ACES bobbled at the start but gave a good effort. FIRING GLOCK got bumped early but gave a steady effort thereafter. TMT RAZZLE DAZZLE drifted in under urging and went evenly. RAZZLEBERRY WINE broke well and was prominent early, but was outkicked late. CORONA N FLASH bumped twice, lost the path in a nightmare trip. BV CATALINA got squeezed and pinched back after the start and lacked a rally. MNTS MASTERPIECE got off to an awkward start and was never a factor. THE TRAINER OF #8 CORONA N FLASH LODGED A CLAIM OF FOUL AGAINST #7 FIRING GLOCK ALLEGING INTERFERENCE. AFTER A REVIEW, THE STEWARDS DISALLOWED THE CLAIM AND THE ORIGINAL RESULTS WERE MADE OFFICIAL.
