MISCHIEVOUS TRICK stalked in the four path, bid in the three path passing the quarter, took a narrow lead while back in the four path passing the eighth pole, and edged clear. ATTENDING rated in the four path, was driven around the far turn, ran on between foes into the final furlong, and got up for place late. SLIVER OF SUNSHINE tracked in the three path, was ridden around the far turn, floated out to the six path at the top of the lane, and kept on for show. MADAM PROSECUTOR bumped with an inner foe at start, pressed the inner pacesetter from the three path, led in the two path around the far turn, dug in from the three path into the final furlong, but yielded in the final sixteenth. MY GAL trailed in the two path, was driven along the inside around the far turn, and improved from the three path down the lane late. JAANTJE bumped with an outer foe at the start, raced in midpack in the three path early, lost ground up the backstretch, was ridden around the far turn, angled out to the seven path passing the eighth pole, and mildly gained. TERRIE T set the pace in the two path, lost the lead while along the inside entering the far turn, then faded. ALICE FAIRFAX (GB) chased in the four path, was driven around the far turn, but weakened.
